AND, I further covenant and agree, that I will, at any time, upon request, communicate to said ASSIGNEE, its successors, assigns, or other legal representatives, at its expense, such facts relating to said invention and Letters Patent or the history thereof, as may be known to me, and testify as to the same in any interference or other litigation, when requested to do so.
