ASSIGNMENT

WHEREAS, I, Pierre-Luc Georgy, of Toulouse, FRANCE (“Assignor”), have invented certain new and useful improvements in OPTICAL FOCUS OF AN IMAGE ACQUISITION SYSTEM, for which an application for Letters Patent of the United States has been made, and which may be identified in the United States Patent Office by Application No. 14/092,333, filed November 27, 2013.

I further authorize said Assignee, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent, in its own name if desired, in any and all foreign countries, and additionally to claim the filing date of said United States application and/or otherwise take advantage of the provisions of the International Convention.

divisional, reissued or extended Letters Patent of the United States, or of any and all foreign countries on said invention, and in enforcing any rights occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.
