**THIS DEED OF ASSIGNMENT** is made on 19<sup>th</sup> April 2011

**BETWEEN:**

- (1) **i3 Group Limited** a company registered in England (company number 6587286) whose registered office is at Unit 1B Mochdre Commerce Park, Ty Gwyn Road, Mochdre, Colwyn Bay, Clwyd, Wales, LL28 5HX (the **Assignor**); and
- (2) **Mochdre Limited** a company registered in England (company number 7599781) whose registered office is at Northern Diver Buildings, Appley Lane North, Appley Bridge, Wigan WN6 9DF (the **Assignee**).

**RECITALS**

- (A) The Assignor is the legal and beneficial owner of the Patent.
- (B) The Assignor has agreed to assign all its right, title and interest in and to the Patent to the Assignee.

**1. Definitions and interpretation**

1.1 In this Deed of Assignment, the following expressions shall have the following meanings:

**Encumbrance** any lien, mortgage, debenture, charge, rent charge, right of pre-emption, bill of sale, assignment for the purpose of security, pledge, or other encumbrance securing the repayment of monies or other obligation or liability of the Assignor; and

**Patent** the registered patent or patent application set out in the schedule to this Deed of Assignment.

1.2 The schedule to this Deed of Assignment forms part of this Deed of Assignment and the expression **Deed of Assignment** includes the schedule.

**2. Assignment**

In consideration of the payment of £1.00 by the Assignee to the Assignor (the receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee with full title guarantee and free from any Encumbrance and third party rights all right, title and interest in and to the Patent, including, without limitation:

- (a) all rights of action arising or accrued in relation to the Patent, including (but not limited to):
  - (i) all statutory and common law rights and all goodwill attaching to any and all of the Patent including without limitation the right to sue for damages and other remedies in respect of past, present and future infringements of any and/or all of such rights; and
  - (ii) the right to seek and recover damages or any other remedies in respect of any infringement of the Patent prior to the date of this Deed of Assignment; and

- (b) the right to apply for prosecute and obtain protection throughout the world in respect of the Patent including the right to claim priority from the Patent and to the intent that any registered protection shall be in the name of and vest in the Assignee.

**3. Further assurance and power of attorney**

3.1 The Assignor covenants that at the request of the Assignee it will:

- (a) at its cost and expense, do or procure the doing of all such further acts and execute or procure the execution (as a deed or otherwise) of all such documents as may from time to time be reasonably necessary to give full effect to the terms of this Deed of Assignment; and
- (b) assist the Assignee (at the Assignee's cost and expense) to prosecute, protect and defend the Assignee's rights in the Patent assigned to it under this Deed of Assignment.

3.2 Notwithstanding clause 3.1 the Assignor hereby appoints the Assignee as its attorney, and in its name and on its behalf, to take such steps and agree, execute, sign and issue such agreements, documents or instruments that the Assignee considers necessary to give the Assignee the full benefits of all the provisions of this Deed of Assignment.

**4. Governing law**

This Deed of Assignment (and any non-contractual claims and disputes) shall be governed by and construed in accordance with the laws of England and Wales and the courts of England shall have exclusive jurisdiction in relation to any dispute that may arise under or in connection with it.

**IN WITNESS** whereof this Deed of Assignment has been exercised as a **DEED** the day and year first above written.


