TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, digEcor I.P. and Assets Pty. 2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
