Pursuant to Section 18-209 of the Delaware Limited Liability Company Act, as amended (the "DLLCA"), Central Sprinkler LLC, a Delaware limited liability company (the "Company"), hereby certifies as follows:

FIRST: The name and state of organization of each of the constituent companies to the merger (the "Constituent Companies") are as follows:


