**RELEASE OF PATENT SECURITY AGREEMENT**

(Senior Subordinated Debt)

THIS RELEASE OF PATENT SECURITY AGREEMENT (this "Release"), dated as of February 20, 2015, is made by **FIFTH THIRD BANK**, an Ohio banking corporation, through its Mezzanine Finance Group ("Secured Party"), and is as follows:

WHEREAS, SIMPSON PERFORMANCE PRODUCTS, INC., a Texas corporation ("Debtor"), and Secured Party are parties to that certain Patent Security Agreement dated as of September 13, 2012 which was recorded with the United States Patent and Trademark Office on November 30, 2012 in its records at Reel 029383, Frame 0733 (the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted and assigned to the Secured Party a security interest in all of the Debtor's right, title and interest in, to and under the Patent Collateral, including, without limitation: (a) all of Debtor's right, title and interest in and to all of its now owned or in the future owned or existing patents and patent applications, including the inventions and improvements described and claimed in those patents and patent applications listed on Schedule I, attached hereto and made a part hereof (the property in this item (a) being, each a "Patent" and, collectively, the "Patents"); (b) all reissues, divisions, continuations, renewals, extensions and continuations-in-part of each of the Patents; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Patents, including damages and payments for past or future infringements of any and all of the Patents; (d) all rights to sue for past, present and future infringements of any and all of the Patents; (e) all rights corresponding to each of the Patents throughout the world; (f) all rights of Debtor as licensor or licensee under, and with respect to, any patents or patent applications, including the licenses listed on Schedule I and the Patent Licenses and (g) all books, records, cash and non-cash proceeds of any and all of the foregoing; and

WHEREAS, Secured Party desires to release its rights and security interests in the Patent Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under all of the Patent Collateral, including, without limitation, the Patents on Schedule I, and (ii) any and all other rights it may have under the Agreement.

This Release shall be governed by the domestic laws of the State of Ohio (without regard to Ohio conflicts of law principles).
