ASSIGNMENT

Now, therefore, in consideration of the sum of one (\$1.00) dollar and other good and valuable consideration, receipt of which is hereby acknowledged, I, **OSWIN LÄNGLE**, by these presents do sell, assign and transfer unto **LÄNGLEGLASS GmbH**, the entire right, title and interest in and to the PATENT RIGHTS, the same to be held and enjoyed by ASSIGNEE, for its own use and for the use of its successors and assigns, to the full end of the terms for which the aforementioned PATENT RIGHTS are or may be granted, as fully and entirely as if the same would have been held by me, had this assignment and sale not been made.

FURTHER, said ASSIGNOR does hereby sell, assign and transfer its rights to sue and collect damages for any past or present infringement with respect to said PATENT RIGHTS.

It is hereby authorized and requested that the Director of the United States Patent and Trademark Office issue any and all said Letters Patent, when granted, to said ASSIGNEE.

Further, it is agreed that, when requested, without charge but at the expense of said ASSIGNEE, the undersigned will execute all divisional, continuing, substitute, renewal and reissue patent applications; execute all documents and other papers necessary to perfect title, and generally do everything possible for aiding in securing and maintaining proper patent protection.
