Whereas Assignee has provided such valuable consideration to the Assignor;

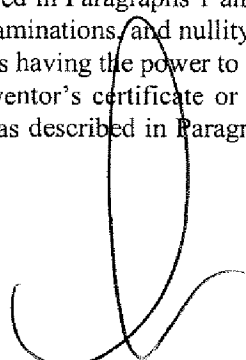
Accordingly, the Assignor warrants, covenants and agrees as follows:

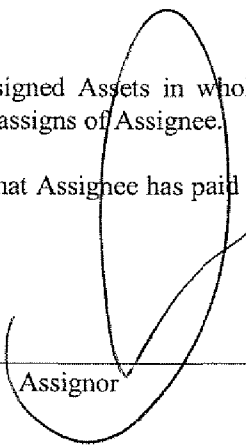

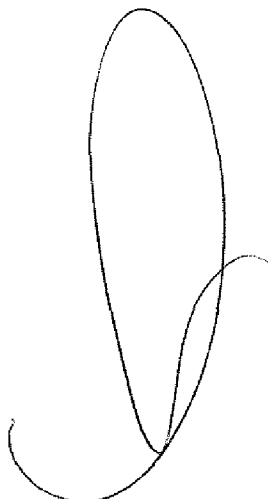
