ASSIGNMENT

Assignor appoints Assignee, and Assignee's successors and assigns, as its attorney-in-fact to act in Assignor's name and to execute, deliver, and record any document or instrument of assignment or conveyance necessary to perfect, grant, and confirm the rights granted herein.

Assignor further covenants and agrees that Assignor will communicate to the Assignee, its successors, legal representatives, and assigns, any facts known to Assignor respecting the Patent, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection in the United States.

Assignor covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed and will not execute any agreement in conflict herewith.
