
8. Definitions.

- d. - e. <u>Trade Secrets</u>: Any formula, pattern, device or compilation of information which is used in one's business and which gives one an opportunity to obtain any advantage over competitors who do not know and use it. Trade Secrets include results that are achieved by the use of a known process or technique.
