## ASSIGNMENT

WHEREAS, WE, **Jung-Hoon CHOI**, a citizen of Korea, having a correspondence address of 501-401, 10, Cheonwang-ro, Guro-gu, Seoul 152-130, Korea; **Dong-Hee KIM**, a citizen of Korea, having a correspondence address of 348-1103, 64, Jeongjacheon-ro 188beon-gil, Jangan-gu, Suwon-si, Gyeonggi-do 440-842 Korea; **Hyun-Ho CHANG**, a citizen of Korea, having a correspondence address of 301, 41, Ujangsan-ro 2-gil, Gangseo-gu, Seoul 157-280, Korea, have invented certain new and useful improvements in MICRO USB CONNECTOR AND ELECTRONIC DEVICE INCLUDING THE SAME, for which WE filed U.S. Patent Application Serial No. 14/460,547, filed August 15, 2014

AND WE HEREBY covenant that WE have full right to convey the entire interest herein assigned, and that WE have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that WE will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to me respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in the United States.
