AND WE HEREBY further assign and transfer to Veritas AG all priority rights derived from such application therefore by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International convention and do hereby assign and transfer to Veritas AG the sole right to file further applications for


