WHEREAS, Assignee is desirous of obtaining such Patents.



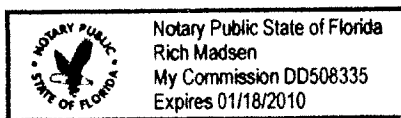
