We hereby assign and transfer to said assignee, its successors and assigns, for any application for patent or other form of protection directed to said Invention(s), the right of priority to and benefit of any and all applications as aforesaid, including without limitation that provided by (a) the International (Paris) Convention for the Protection of Industrial property, as amended, or by convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it; and the right to invoke and claim the same, and further authorize and empower the assignee, its successors and assigns, and their legal representatives or nominees so to invoke or claim such right and benefit without further written or oral approval from us.

We hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country or other jurisdiction for any purpose and more particularly in proof of the right of the said assignee, legal representative or nominee to invoke and claim the right of priority to and benefit of the aforementioned provisional application and any and all other applications as aforesaid including that provided by: (a) the International Convention for the protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it.

We covenant with said assignee, its successors and assigns and legal representatives, that the rights and property herein conveyed are free and clear of any encumbrance, and that We have full right to convey the same as herein expressed.

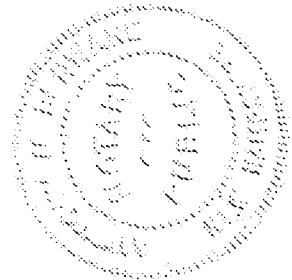
