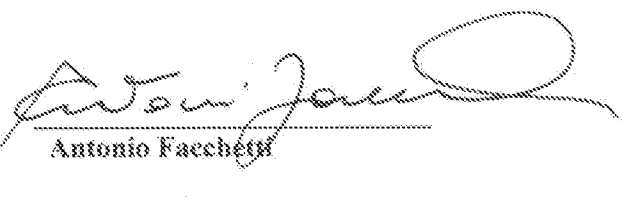
provisional, substitution, continuation, divisional, reissue, reexamination, and corresponding foreign and international patent applications;
