WHEREAS, PRO SPORTS INC. d/b/a CHAMPION SPORTS, a corporation of the State of New Jersey, having a place of business at: 1 Champion Way, Marlboro, New Jersey 07746, (hereinafter referred to as "Company"), is desirous of acquiring the entire right, title and interest in and to said inventions and in and to the Letters Patent that have been granted or may be granted therefor in the United States and in any and all foreign countries.

FURTHER, I agree that I will communicate to said Company or its representatives any facts known to me respecting said inventions and for reasonable compensation will (1) testify in any legal proceedings, (2) sign all lawful papers, (3) execute all divisional, continuation, substitution, renewal and reissue applications, (4) execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Company, (5) make all rightful oaths and (6) generally do everything possible to aid said Company, its successors and assigns, to obtain and enforce proper protection for said inventions in the United States and in any and all foreign countries.
