8. The Assignee shall have the right to assign this Assignment and the rights hereunder, and each later assignee shall have the rights of the Assignee hereunder.

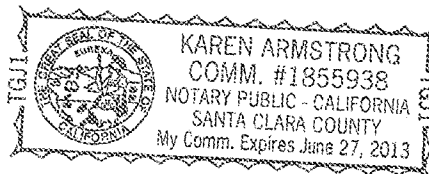
