**CERTIFICATE OF AMENDMENT  
OF RESTATED CERTIFICATE OF INCORPORATION  
OF DATACARD CORPORATION**

DataCard Corporation (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

FIRST: The Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of Delaware on March 11, 1969 and the Restated Certificate of Incorporation of the Corporation was filed on March 3, 2009.

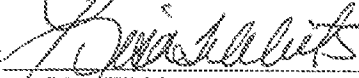
SECOND: That the Board of Directors of the Corporation unanimously adopted and approved by written consent resolutions in lieu of a meeting pursuant to Section 141(f) of the General Corporation Law of the State of Delaware a proposed amendment of the Restated Certificate of Incorporation of the Corporation. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Restated Certificate of Incorporation of the Corporation be amended by changing the Article One thereof so that, as amended, said Article shall be and read as follows:

"1. The name of the corporation is Entrust Datacard Corporation."

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
