RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY  
(PATENTS)

This RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY (this "Release") is made as of March 12, 2015, by LLOYDS BANK PLC, as Security Agent ("Security Agent") for each of the Secured Parties, in favor of RFD BEAUFORT INC., a Delaware corporation ("Grantor"). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Security Agreement, dated 25 March 2010 (the "Security Agreement"), among the Grantor, Survitec Group (USA), Inc. and the Security Agent.

WHEREAS reference is made to the Facilities Agreement, dated 28 January 2010 (as amended and restated from time to time including by way of an amendment and restatement agreement dated 3 August 2011 and an amendment and restatement agreement dated 8 August 2013) (the "Facilities Agreement") and made between, amongst others, Survitec Group (Finance 3) Limited, Survitec Group (Holdings) Limited, the Grantor, as guarantor, the Security Agent and Lloyds Bank plc, as facility agent;

WHEREAS, pursuant to (i) the Security Agreement and (ii) a Grant of Patent Security Interest, dated as of March 25, 2010, by RFD Beaufort Inc. in favour of the Security Agent (the "IP Security Agreement"), Grantor has granted to the Security Agent, for the benefit of the Secured Parties, a security interest in and to all of such Grantor's right, title and interest in and to the Patent Collateral (as defined in the IP Security Agreement), including patent registration and patent applications set forth on Schedule A attached hereto (the "Released IP") to secure the prompt and complete payment and performance of the obligations of the Secured Obligations; and


WHEREAS the IP Security Agreement was recorded on May 12, 2010 with the United States Patent and Trademark Office under Reel and Frame number 024369/0162;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent agrees as follows:

- (a) Security Agent, on behalf of the Secured Parties, hereby relinquishes, releases, discharges and assigns to Grantor its security interest and lien in, to and under the Released IP.
- (b) Security Agent hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.
- (c) This Release shall be governed by, and construed in accordance with the law of the State of New York.

IN WITNESS WHEREOF, the Security Agent has caused this RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY to be duly executed as of the date first written above.
