ASSIGNMENT

WHEREAS, Gary L. Glick, residing at Rolling Hills Est., CA; Joel Mendoza, residing at Sylmar, CA; Jerry D. Macfarlane, residing at Rancho Palos Verdes, CA; Richard A.
