PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT (this "Assignment") is entered into as of June 28, 2013 (the "Effective Date"), by and between Atlantic City Coin & Slot Service Company, Inc. a New Jersey corporation having its principal place of business at 201 W. Decatur Avenue, Pleasantville, New Jersey 08232 ("Assignor") and IGT, a Nevada corporation having its principle place of business at 6355 South Buffalo Drive, Las Vegas, Nevada 89113 ("Assignee") and together with Assignor, each a "Party" and collectively the "Parties").

WHEREAS, Assignor holds ownership rights in and to (i) the patents and patent applications listed on Schedule A and inventions disclosed or claimed therein, and (ii) any and all related issued patents, continuations, continuations-in-part, reissues, renewals, reexaminations, provisionals, divisionals, substitutions, extensions or revisions thereof, any foreign counterparts or equivalents of any of the foregoing, and any other patents, applications or extensions that claim priority to or through any of the foregoing, and any invention disclosed or claimed in any of the foregoing ("Assigned Patents");

WHEREAS, pursuant to that certain Purchase Agreement, made as of June 28, 2013, Assignor has agreed to sell, assign, transfer, convey and deliver to Assignee all of Assignors' right, title and interest in, to and under the Assigned Patents, for the consideration and upon the terms and conditions set forth in the Asset Purchase Agreement; and

WHEREAS, Assignee is desirous of obtaining Assignor's entire right, title and interest in, to and under the Assigned Patents.

NOW THEREFORE, in consideration of the covenants and agreements contained herein and in the Asset Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. ASSIGNMENT

1.1 Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee, its successors, legal representatives and assigns, Assignor's entire right, title and interest in, to and under the Assigned Patents, including, without limitation, Assignor's rights to (a) recover damages for any and all past, current or future infringements or other violations thereof, (b) apply for and maintain all registrations, renewals and/or extensions thereof, (c) file applications, revive abandoned applications and registrations, and make claims of priority to the Assigned Patents under the patent laws of the United States, the International Convention for the Protection of Industrial Property, and any other international agreement or convention or the domestic laws of any country in which such application is filed, and (d) grant licenses or other interests therein.

1.2 Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States (including any official empowered or authorized by international agreement or convention to issue patents pursuant to such agreement or convention), whose duty it is to

issue patents on applications as aforesaid, to record Assignee as the owner of the Assigned Patents, and to issue all letters patent for said Assigned Patents to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument. Assignee shall have the right to record this Assignment with all applicable governmental authorities and registrars so as to perfect its ownership of the Assigned Patents.

2. GENERAL PROVISIONS

- 2.1 Assistance. Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as its agent and attorney in fact, which appointment is coupled with an interest, to act for and on its behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of this paragraph with the same legal force and effect as if executed by the Assignor.
- 2.2 Governing Law. This Assignment and any disputes hereunder shall be governed by and construed in accordance with the domestic laws of the State of Nevada, without giving effect to any choice of law or conflict of law provision or rule (whether of the State of Nevada or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the State of Nevada.
- 2.3 Counterparts. This Assignment may be executed in multiple counterparts (including by means of telecopied signature pages), any one of which need not contain the signatures of more than one Party, but all such counterparts taken together shall constitute one and the same instrument.

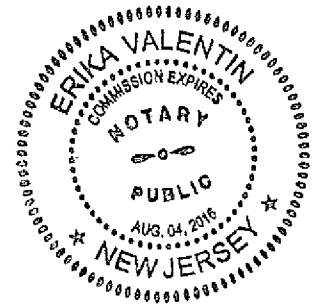


