WADE by these presents sell, assign and transfer unto Assignee, its successors, legal representatives, and assigns, the full and exclusive right, title and interest worldwide (including the right to apply for Letters Patent in foreign countries and regions in its own name and to claim any priority rights for such foreign applications and which claim priority to the above referenced patent application and to which such applications are entitled under international conventions, treaties, or otherwise), in and to the said invention as described in said application, and all related intellectual property, including, but not limited to, all Letters Patent pending now or in the future or granted therefor, and all divisions, reissues and continuations thereof, trademark rights, trade names, copyrights, know how, trade secrets, and reproduction rights, and waive any and all moral rights in the invention, and I hereby authorize and request the Commissioner of Patents and Trademarks and foreign patent officials to issue all Letters Patent on said inventions or resulting therefrom to said Assignee, as assignee of my entire right, title and interest, and I covenant that I have full right so to do. I will communicate to said Assignee, or its successors any and all facts known to me regarding said invention immediately whenever requested, and will testify in any legal proceeding, sign all lawful papers, provide all tangible property describing or embodying the invention, execute all divisional, reissue, continuation, continuation-in-part, and foreign applications, and generally do everything possible to aid said Assignee, its successors and assigns, to

obtain and enforce proper patent protection for said invention in all countries. I also covenant and agree not to contest the validity or enforceability of any intellectual property rights assigned herein, or to assist or request any third party to contest the validity or enforceability of any intellectual property rights assigned herein.

I do hereby release and forever discharge Assignee for any and all claims, including but not limited to, any debts, liabilities, damages and causes of action of whatsoever kind or nature related to the Invention, whether or not known, suspected, and unsuspected, including any and all previous agreements entered into, which now exist or may have existed prior to the date of this Agreement.

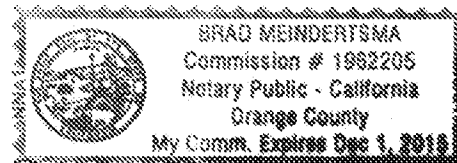
