ETHICON, INC. and JOHNSON & JOHNSON MEDICAL LIMITED
TO SYSTAGENIX WOUND MANAGEMENT IP CO B.V.

This PATENT ASSIGNMENT made as of the first day of December, 2008, by ETHICON, INC., a New Jersey corporation whose address is at US Route 22, Somerville, NJ 08876, and JOHNSON & JOHNSON MEDICAL LIMITED, a private limited company incorporated in the United Kingdom under company number SC132162 and whose registered address is at P.O. Box 1988, Simpson Parkway, Livingston, West Lothian, EH54 OAB, United Kingdom (collectively "Assignor"), to SYSTAGENIX WOUND MANAGEMENT IP CO. B.V., a Netherlands corporation whose address is at Keizersgracht 64, 1015CS Amsterdam, the Netherlands ("Assignee").

RECITALS:

WHEREAS, pursuant to that certain Asset Purchase Agreement dated as of June 29, 2008 (the "Asset Purchase Agreement") between ETHICON, INC., a New Jersey corporation ("Seller"), SOLEIL WC ACQUISITION CORP. II, a Cayman company limited by shares ("Buyer"), and SOLEIL WC ACQUISITION CORP. I, a Cayman company limited by shares, Seller has agreed to sell, convey, assign and transfer (either directly or through one or more of its Affiliates) to Buyer, or an Affiliate of Buyer designated by Buyer, and Buyer has agreed to purchase, acquire and accept (either directly or through one or more of its Affiliates) from Seller, Assignor's worldwide right, title and interest in, to and under certain patents and patent applications, utility models and industrial designs, and all applications and registrations therefor, together with all reissuances, continuations, continuations-in-part, divisions, revisions, extensions and reexaminations with respect thereto as set forth on Schedule A annexed hereto (hereinafter referred to as the "Patents"). Each capitalized term used and not defined in this Patent Assignment shall have the meaning assigned to it in the Asset Purchase Agreement;

WHEREAS, pursuant to the Asset Purchase Agreement, Buyer (or an Affiliate of Buyer) has or will purchase certain assets related to the Business and to which the Patents pertain; and

WHEREAS, in accordance therewith, Assignor desires to transfer and assign to Assignee, which has been designated by Buyer, and Assignee desires to accept the transfer and assignment of all of Assignor's worldwide right, title and interest in, to and under such Patents and in and to the inventions represented thereby.

WHEREAS, Assignor has previously acquired rights to certain of the Patents via (a) a merger of Surgikos, Inc. with and into Johnson & Johnson Products, Inc., and a name change of the latter to Surgikos, Inc., as reflected in the Certificate of Merger dated December 5, 1988, a copy of which is annexed hereto as Schedule C, (b) the transfer of assets from Surgikos, Inc. to Johnson & Johnson Transfer, Inc., as reflected in the Agreement for Transfer of Assets and Bill of Sale dated December 12, 1988, a copy of which is annexed hereto as Schedule D; (c) the name change of Johnson & Johnson Transfer Inc. to Surgikos, Inc., as reflected in the Certificate of Amendment to the Certificate of Incorporation of Johnson & Johnson Transfer, Inc. dated December 14, 2008, a copy of which is annexed hereto as Schedule E, (d) the merger of Johnson & Johnson Patient Care, Inc. and Sterile Design, Inc. into and with Surgikos, Inc., and a name change of the latter to Johnson & Johnson Medical, Inc., as reflected in the Certificate of Merger dated December 4, 1989, a copy of which is annexed hereto as Schedule F and (e) the merger of Ethicon, Inc., Menlo Care, Inc. and Mitek Surgical Products, Inc. with and into Johnson & Johnson Medical, Inc., and a name change of

the latter to Ethicon, Inc., as reflected in the Certificate of Merger dated December 18, 1997, a copy of which is annexed hereto as Schedule B.

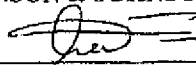
WHEREAS, to the extent that Johnson & Johnson Medical Limited has any rights in any of the Patents set forth in Schedule A by virtue of (i) being the employer of or (ii) having any contractual or other obligation, either directly or indirectly, with at least one inventor of any such Patent, Johnson & Johnson Medical Limited hereby assigns all of its rights in any such Patent to Assignee.

NOW, THEREFORE, Assignor, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby sell, convey, assign and transfer to Assignee, and Assignee hereby accepts the sale, conveyance, assignment and transfer of all of Assignor's worldwide right, title and interest in, to and under the Patents, together with the right to claim priority in all foreign countries in accordance with international Law, any and all rights corresponding to said Patents in foreign countries throughout the world and all of Assignor's rights to sue for past, present or future infringement of said Patents worldwide together with all claims for damages by reason of past, present or future infringement of said Patents and the right to sue for and collect the same for Assignee's own use and enjoyment, all to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this Patent Assignment not been made.

For a period of up to 18 months after the applicable Closing Date, Assignor agrees to provide reasonable assistance to Assignee in connection with the execution and provision of information necessary for Assignee to draft and record required assignment documents pertaining to the Patents at Assignee's own cost and discretion. After such period Assignor shall have no further obligation hereunder.

Except to the extent that U.S. federal law preempts state law with respect to the matters covered hereby, this Patent Assignment shall be governed by and construed in accordance with the laws of the State of New York without giving effect to the principles of conflicts of laws thereof.

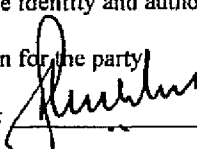

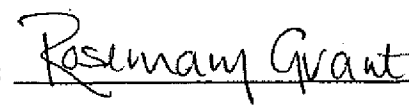

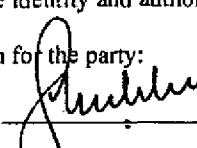
