The Assignor further agrees, without further consideration, to take such further action and to execute such further assignments and other lawful documents as the Assignee may reasonably request to effectuate fully this Confirmatory Assignment.

The Assignor authorizes and requests the Commissioner of Patents to record the Assignee as the assignee and owner of all rights, title and interest in the Patent Assets.


THIS Confirmatory Assignment is effective as of December 21, 2012.


