NOTICE OF RELEASE OF
SECURITY INTEREST IN PATENTS

This NOTICE OF RELEASE OF SECURITY INTEREST IN PATENTS (the "Release"), effective as of March 26, 2015, is made between Fifth Third Bank, an Ohio banking corporation, in its capacity as agent (in such capacity, "Agent") for the lenders (the "Lenders"), in favor of AM Conservation Group, Inc., a New Jersey corporation (the "Borrower"), pursuant to that certain Loan, Guaranty and Security Agreement, dated December 5, 2013, among the Agent, the Lenders, AM Conservation Holding Corporation, a Delaware corporation, AM Purchaser Corp., a Delaware corporation, and the Borrower (and as the same may be further amended or modified from time to time, the "Loan Agreement").

WITNESSETH:

WHEREAS, in connection with the Loan Agreement, the Borrower has executed and delivered (i) a Patent Security Agreement, dated as of January 28, 2011, recorded in the Patent Division of the United States Patent and Trademark Office (the "USPTO") on February 3, 2011 at Reel/Frame No. 025738/0296; (ii) a Patent Security Agreement, dated as of December 5, 2013, recorded in the USPTO on December 9, 2013 at Reel/Frame No. 031739/0134; (iii) a Patent Security Agreement, dated as of December 5, 2013, recorded in the USPTO on December 6, 2013 at Reel/Frame No. 031731/0613; and (iv) a Patent Security Agreement, dated as of December 5, 2013, recorded in the USPTO on January 17, 2014 at Reel/Frame No. 032087/0078 (as amended by the corrective filings made with the USPTO on March 11, 2015, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, the Borrower granted to the Agent for the benefit of the Lenders a security interest in and lien on all of its right, title and interest in all of its patents and patent applications (including but not limited to its Patents (as defined in the Security Agreements)), as collateral security for the payment and performance in full when due of the Obligations, including but not limited to the patents and patent applications set forth on Exhibit A attached hereto (the "Released Patents"); and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees, for the benefit of the Borrower, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Loan Agreement and Security Agreements, as applicable (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Security Agreements).

SECTION 2. Release of Security Interest. The Agent does hereby release, relinquish and discharge its security interest in and lien on all of its right, title and interest in the Released Patents.

SECTION 3. Purpose. This Release has been executed and delivered by the Agent for the purpose of recording this Release with the USPTO.


SECTION 4. Further Assurances. The Agent hereby authorizes the Borrower or the Borrower's authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Agent in the Released Patents and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to the Borrower any and all further documents and instruments, and do any and all further acts which the Borrower (or their agents or designees) reasonably request (at the Borrower's sole cost and expense) in order to confirm this Release and the Borrower's right, title and interest in, to and under the Released Patents.

SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

SECTION 6. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
