ASSIGNMENT

Now, therefore, in consideration of the sum of one (\$1.00) dollar and other good and valuable consideration, receipt of which is hereby acknowledged, I, **Andrew Sean MacAuley**, by these presents do sell, assign and transfer unto **Aquapac International Limited** the entire right, title and interest in and to the PATENT RIGHTS, the same to be held and enjoyed by ASSIGNEE, for its own use and for the use of its successors and assigns, to the full end of the terms for which the aforementioned patent rights are or may be granted, as fully and entirely as if the same would have been held by me, had this assignment and sale not been made.


