TruStile Doors, Inc., a Colorado corporation ("TruStile"), and Wood Door Products, Inc., a Colorado corporation ("WDP") pursuant to the provisions of Section 7-111-104 of the Colorado Business Corporation Act, as amended (the "Colorado Act"); do hereby certify as follows:

1. The terms of a Plan of Merger by and between TruStile and WDP are attached hereto as Exhibit A.

2. The Plan of Merger was unanimously approved by the board of directors and shareholders of TruStile.

3. The Plan of Merger was unanimously approved by the board of directors and shareholders of WDP.

4. TruStile owns 100% of the issued and outstanding stock of WDP.

5. The Merger shall become effective on the date these Articles of Merger are filed in the office of the Secretary of State of the State of Colorado in accordance with the provisions of and with the effect provided in Section 7-111-104(5) of the Colorado Act (the "Effective Date"). The "Effective Time" of the Merger shall be the time these Articles of Merger are filed as set forth above.

6. The surviving entity shall be TruStile Doors, Inc.

7. The principal place of business of the surviving entity is 1780 E. 66<sup>th</sup> Avenue, Denver, Colorado 80229.

**EXHIBIT "A"**  
**PLAN OF MERGER**

1. WOOD DOOR PRODUCTS, INC., a Colorado corporation ("WDP") shall be merged with and into TRUSTILE DOORS, INC., a Colorado corporation (the "Corporation"), with the Corporation being the surviving corporation.

2. The merger shall be effective immediately upon filing the Articles of Merger (the "Effective Date"). On the Effective Date, the separate existence of WDP shall cease, and WDP shall be merged with and into the Corporation, which, as the Surviving Corporation, shall possess all the assets, properties, rights, privileges, powers and franchises, of a public or of a private nature, and be subject to all liabilities, restrictions, disabilities and duties of WDP.

3. On the Effective Date, each share of the Corporation's Common Stock which shall be issued and outstanding shall remain issued and outstanding.
