DEED OF CONFIRMATION

THIS DEED dated the 24TH day of FEBRUARY ~~2014~~ 2015

Between the parties named in item 1 of the Schedule (Assignors)

and the party named in item 2 of the Schedule (Assignees)

BACKGROUND

 - (a) any rights to file any corresponding application based on the *Designs*, and any rights arising from any such filing;
 - (b) any rights to be granted designs in respect of the *Designs* and any corresponding application based on the *Designs* and all rights arising from any such design; and
 - (c) any rights to sue for infringement of any of the rights described in paragraphs (a) and (b) above, occurring before the date of this Deed.
- 2. This Deed may be executed in counterparts and together all counterparts are taken to constitute a single Deed.
- 3. This Deed is governed by the laws of Victoria, Australia and the parties submit to the non-exclusive jurisdiction of the courts of that State.






