**THIS** agreement ("**Agreement**") is effective as of the date of the last signature entered below ("**Effective Date**")

**BETWEEN**

**PARTIES**

- (1) **SONORIT APS** whose registered office is at c/o Abel & Skovgaard Larsen, Amallegade 13, DK - 1256 Kobenhavn K, Denmark ("**Assignor**"); and
- (2) **SKYPE LIMITED** incorporated and registered in the Republic of Ireland whose registered office is at Arthur Cox Building, Earlsfort Centre, Earlsfort Terrace, Dublin 2, Republic of Ireland ("**Assignee**").

**BACKGROUND**

- (A) The Assignor is the proprietor of the patents (including any applications for such patents) set out in Schedule 1 (together the "**Patents**");
- (B) The Assignor has agreed to assign the Patents to the Assignee on the terms set out in this Agreement.

**AGREED TERMS**

**1. ASSIGNMENT**

In consideration of the sum of £1 inclusive of value added tax (receipt of which the Assignor hereby acknowledges), the Assignor assigns all the right, title and interest in and to the Patents, including all rights privileges and advantages attaching to them (including the right to bring proceedings for infringement prior to the date hereof) to hold unto the Assignee absolutely, and to the intent that the Assignee shall (i) be absolutely entitled to any patent granted on any of the patent applications for the full term of such patents; and (ii) have the right to apply for, prosecute and obtain patent or like protection throughout the world for any invention embodied by any of such applications, including the right to claim priority from such applications.

**2. FURTHER ASSURANCE**

The Assignor shall at the cost and expense of the Assignee do or procure to be done all such further acts and things, and execute or procure the execution of all such other documents, as the Assignee may from time to time reasonably require in order to give the Assignee the full benefit of this Agreement, whether in connection with any registration of title or other similar right or otherwise.
