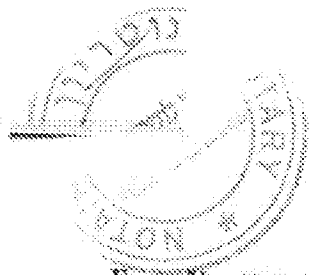

Ruling

Based on the parties' consent, and my decision as mentioned in the minutes of the hearing dated December 30th 2014, I hereby rule as follows:

1. Having received the Chief Scientist's approval, the sale as specified in the RFP documents, was sold to the buyer wave2wave for an NIS total equal to USD 360,000 plus legal VAT, as is with no obligation on the Company's part regarding the sale's quantity, quality and/or correctness.
2. Sale will be free of any third party right, lien, foreclosure, pledge etc. in Israel or outside Israel.
3. Ownership of the assets held by third parties will transfer to the buyer, but without the buyer having a claim or the right to legal action against the Company in that matter.
4. Owners of liens 6 and 8 gave their consent to the sale of intellectual property, provided they have the right to monitor the monies and provided that the Liquidator follows the agreement between lien owners and the Company.
5. The buyer is obligated to offer a paid service agreement to clients that have purchased devices from the Company.
6. The court authorizes the special manager to sign all of the documents necessary for the transfer of rights in the Company's assets to the buyer.
