ASSIGNMENT

PARTIES:

- (1) **Raymond Anthony SPITS and Carlton Nigel DODGE** both of Element Six Limited, Isle of Man Freeport, P O Box 6, Ballasalla IM99 6AQ, Isle of Man (hereinafter collectively and severally "the INVENTOR")
- (2) **ELEMENT SIX LIMITED**, Isle of Man Freeport, P O Box 6, Ballasalla IM99 6AQ, Isle of Man ("the ASSIGNEE")

WHEREAS:

A. The INVENTOR is an inventor of the invention ("the INVENTION") which is the subject of the following patent application(s) (hereinafter collectively and severally "the APPLICATION"):

- B. - C. For the avoidance of doubt and so as to confirm the ASSIGNEE's legal title to the same, the parties have agreed to execute this Assignment for the purpose of ensuring that all the INVENTOR's rights in the INVENTION (including the APPLICATION and all other intellectual property rights) are vested in the ASSIGNEE.

IT IS AGREED THAT:

In consideration of the sum of US\$1 (one US dollar) paid by the ASSIGNEE to the INVENTOR, receipt of which is hereby acknowledged:

- 1.1 The INVENTOR hereby assigns to the ASSIGNEE, effective as of the date of the INVENTION ("the EFFECTIVE DATE") and the ASSIGNEE hereby confirms its acceptance and accepts from the EFFECTIVE DATE all the INVENTOR's property, right, title, and interest in and to the INVENTION and the APPLICATION for all relevant states including without limitation:
 - (a) the right to apply for and obtain patents in respect of the INVENTION in any country in the world;
 - (b) all right title and interest in the APPLICATION and all patent applications, patents and supplementary protection certificates which may now or at any time in the future derive or result or claim priority from the same or otherwise relate to the INVENTION, including any divisionals, continuations, reissues, re-examination certificates, extensions, renewals and

registrations in relation to any thereof and all and any other rights in the inventions comprised in any of the same (hereinafter collectively and severally "the PATENT RIGHTS");

(c) the benefit of all priority dates;

(d) the right to seek and to obtain registrations in any country in the world in respect of any patent deriving from the APPLICATION or otherwise included in the PATENT RIGHTS;

(e) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past present or future) of any of the PATENT RIGHTS or of the rights conferred by the publication of any of the same.

1.2 The INVENTOR agrees to execute all such documents as may be required to ensure the vesting in the ASSIGNEE of the PATENT RIGHTS, all at the expense of the ASSIGNEE.

1.3 This Assignment shall be governed by English law.
