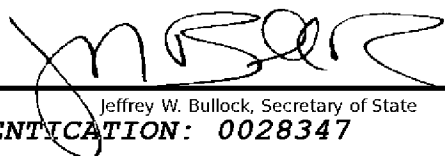

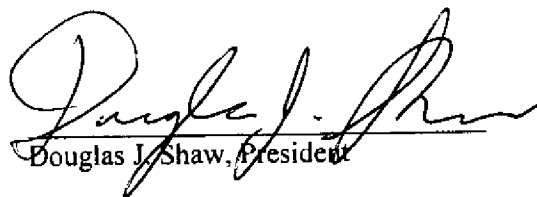
1. He is the duly elected and acting President of BITSTREAM INC., a Delaware corporation.
