PATENT ASSIGNMENT NUNC PRO TUNC

This PATENT ASSIGNMENT NUNC PRO TUNC (hereinafter "Assignment") is made this 20th day of March, 2015, to be effective as of midnight of December 31, 2014, nunc pro tunc, by WL Laney, an individual United States citizen who resides at 2879 Breezy Lane, Castle Rock, CO 80109 (hereinafter "Assignor").

This Assignment is made to Coleen Laney, an individual United States citizen who resides at 2879 Breezy Lane, Castle Rock, CO 80109 (hereinafter "Assignee").

This Assignment is made with reference to the following facts.

A. Assignor is the owner of Patent No. 7,118,466 for the Scissor Sharpening Machine that was issued by the U.S. Patent and Trademark Office on October 10, 2006 (hereinafter the "Patent").

B. Assignor has used the Patent in interstate commerce in conjunction with his Diamond Rose Shears business which was also owned with Coleen Laney.

C. Up until midnight of December 31, 2014, Assignor owned all right, title, and interest in and to the Patent.

D. Effective midnight of December 31, 2014, Assignee became the sole owner of all assets previously owned by Assignor. In conjunction with the various conveyances and transfers carried out for effecting such change in ownership, both parties intended that Assignor convey to Assignee, effective midnight of December 31, 2014, all right, title, and interest in and to the Patent, including U.S. Patent No. 7,118,466 for the Scissor Sharpening Machine that was issued to Assignor on October 10, 2006. To the extent that any such conveyance was not heretofore effected, the present Assignment is being entered.

E. Assignee is to succeed to the ownership of the Patent, and Assignor hereby also assigns the right to sue for any and all past infringements that may exist or become known of in the future.

F. Assignor desires to transfer and convey to Assignee, and Assignee desires to receive from Assignor, all of the right, title, and interest in and to the Patent as aforesaid, together with the right to sue for all past infringements, and the aforesaid U.S. Patent No. 7,118,466, all to be effective as of midnight of December 31, 2014.

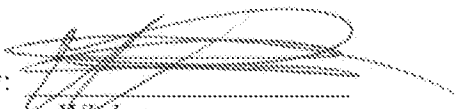

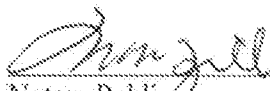
