## SCHEDULE B

### PATENT RIGHTS ASSIGNMENT

**THIS PATENT RIGHTS ASSIGNMENT** (this "*Assignment*") is made by and between Raptor Ridge, LLC, a Delaware limited liability company ("*Raptor Ridge*") and Datascope Corp., a Delaware corporation ("*Datascope*").

WHEREAS, Raptor Ridge possesses certain rights in and to the domestic and foreign patents (including certificates of invention and other patent equivalents) and patent applications set forth on Exhibit 1 attached hereto and incorporated herein by reference (collectively, the "*Patent Rights*") and the invention(s) described and/or claimed in the Patent Rights (the "*Inventions*");

WHEREAS, Raptor Ridge, William K. Wheeler, an individual, and Datascope are parties to a certain Intellectual Property Assignment Agreement, dated as of the date hereof (the "*IP Assignment Agreement*"), pursuant to which Raptor Ridge and its Affiliates transferred to Datascope certain intellectual property (the "*Assigned IP*");

WHEREAS, Raptor Ridge and Datascope now wish to confirm the assignment of the Inventions and Patent Rights to Datascope; and

WHEREAS, Raptor Ridge is obligated to execute and deliver this Assignment pursuant to the IP Assignment Agreement.

NOW, THEREFORE, in consideration of at least U.S. \$1.00, the premises set forth above and in the IP Assignment Agreement and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:


Raptor Ridge hereby sells, assigns, conveys and transfers unto Datascope and its successors, assigns, and legal representatives, Raptor Ridge's entire right, title and interest in and throughout the world in and to the Inventions, together with Raptor Ridge's entire right, title and interest in and to the Patent Rights and patents or patent applications claiming priority under United States law or international convention, including, without limitation, all divisionals, continuations, continuations-in-part, reissues, reexaminations, extensions, substitutions, revivals and renewals of any patent or patent application relating to any of the foregoing; and patents issuing or resulting from any of the foregoing to be held and enjoyed by Datascope for its own use and behalf and for its successors, assigns and legal representatives, to the full end of the term for which said patents may be granted as fully and entirely as the same would have been held by Raptor Ridge had this assignment and sale not been made; and Raptor Ridge hereby conveys all of its rights arising under or pursuant to any and all United States laws and international agreements, treaties or laws relating to the protection of industrial property by filing any such applications for patent, including but not limited to all claims for damages or payments by reason of infringement of the Patent Rights accruing prior to this assignment, and all rights to sue and recover damages or obtain relief for past, present and future infringements and collect same for Datascope's sole use and enjoyment. Raptor Ridge hereby acknowledges that this assignment, being of Raptor Ridge's entire right, title and interest in and to the Inventions and the Patent Rights carries with it the right in Datascope to apply for and obtain from competent authorities in all countries of the world any and all patents by attorneys and agents of Datascope's selection and the right to procure the grant of all patents to Datascope in its own name as Datascope of Raptor Ridge's entire right, title and interest therein.

Raptor Ridge hereby authorizes the Director of the United States Patent & Trademark Office, and the empowered officials of all other governments whose duty it is to record patents, applications and title thereto, to record the Patent Rights and title thereto as the property of Datascope, its successors, assigns, or legal representatives in accordance with the terms of this instrument.

Raptor Ridge hereby further authorizes and requests the Director of the United States Patent and Trademark Office and the empowered officials of all other governments to issue such Patent Rights or patents as shall be granted upon the Patent Rights, or applications based thereon, to Datascope, its successors, assigns, or legal representatives.

Raptor Ridge and Datascope also agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon Datascope and Raptor Ridge.

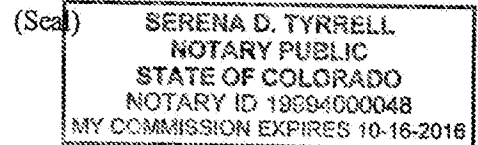

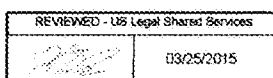

