NOW THIS DEED WITNESSETH as follows:

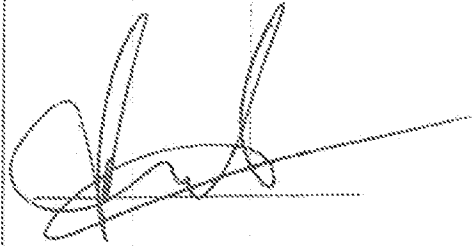

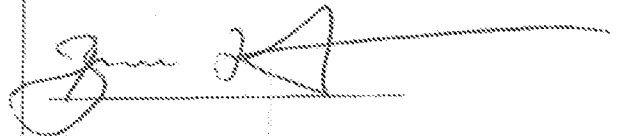

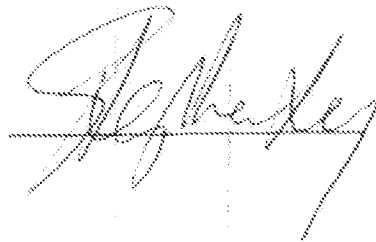
