I agree by fixing my signature below, to allow the firm of Hemingway & Hansen, LLP, if no serial number has yet been assigned and inserted into the first paragraph of this agreement, to

insert the filing date and Serial Number assigned by the United States Patent and Trademark Office to the patent application identified by the attorney docket number above, in the blanks in the first paragraph of this document after my signature is affixed hereto.

I also covenant that no assignment, sales agreement, or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

I hereby further agree that I will communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to me respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
