

United States or any foreign country.

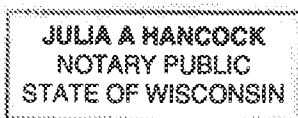


