The Assignor agrees that he will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain the Inventions & Patents and for additions and modifications thereto in any and all countries worldwide, and to vest title thereto in the Assignee, its successors, assigns and legal representatives or nominees.
