DECLARATION BY MICHAEL CZOP

1. I, MICHAEL CZOP, am the President at TIDI CFI Products, LLC.
2. I have personal knowledge of the following facts and understand that this declaration is made under penalty of perjury.
3. Before the company was called TIDI CFI Products, LLC, it was called RawCar Group, L.L.C. The name was changed to TIDI CFI Products, LLC on October 28, 2014 as reflected by the Certificate of Amendment to the Articles of Organization filed with the Michigan Department of Licensing and Regulatory Affairs, Corporations, Securities & Commercial Licensing Bureau. A copy of this document is attached here as Exhibit A.
4. RawCar Group, L.L.C. did business under a number of different assumed names. For instance, RawCar Group, L.L.C. began doing business under the name Contour Fabricators, Inc. in 1997. *See* Exhibit B which provides a copy of the Certificate of Assumed Name dated July 14, 1997. After the Certificate of Assumed Name in Exhibit B expired on December 31, 2012, a subsequent Certificate of Assumed Name for Contour Fabricators, Inc. was filed on January 8, 2013. *See* Exhibit C.
5. Since RawCar Group, L.L.C. began doing business under the assumed name Contour Fabricators, Inc. in 1997, a number of intellectual property assets have been filed in the name of Contour Fabricators, Inc. Exhibit D provides a list of some of the assets that are currently listed in the name of Contour Fabricators, Inc.
6. The intellectual property assets contained in Exhibit D were developed and invented by employees of RawCar Group, L.L.C., former employees of RawCar Group, L.L.C., or consultants for RawCar Group, L.L.C.

7. Because Contour Fabricators, Inc. was an assumed name, the intellectual property assets currently assigned or owned by Contour Fabricators, Inc. should have been assigned or owned by RawCar Group, L.L.C.
8. Further, as RawCar Group, L.L.C. has changed its name to TIDI CFI Products, LLC, all of the assets included in Exhibit D should now be owned by, or assigned to TIDI CFI Products, LLC.
9. The assets listed in Exhibit D are exemplary, and any other intellectual property assets currently owned by Contour Fabricators, Inc. as an assumed name of the former RawCar Group, L.L.C. or the current TIDI CFI Products, LLC should also be owned by, or assigned to TIDI CFI Products, LLC. This may include, for instance, any unregistered intellectual property, any foreign intellectual property rights, any grants to intellectual property rights such as through license agreements, and any other intellectual property not specifically listed on Exhibit D.

I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any registration resulting therefrom.


