ASSIGNMENT AND AGREEMENT

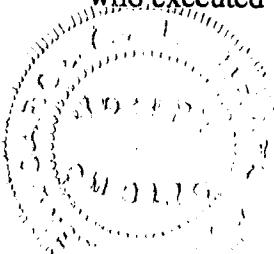
