

**CERTIFICATE OF AMENDMENT TO  
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF  
BAKER-CALLING, INC.**

Baker-Calling, Inc., a corporation duly organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**Company**"), DOES HEREBY CERTIFY:

**FIRST:** The original name of this corporation is Baker-Calling, Inc.

**SECOND:** Pursuant to applicable provisions of Section 242 of the General Corporation Law of the State of Delaware, the Amended and Restated Certificate of Incorporation of the Company is hereby amended by amending Article First to read in its entirety as follows:

"The name of this corporation is Vesper Technologies Inc. (the "**Company**")."

**THIRD:** The board of directors of the Company adopted resolutions in accordance with applicable provisions of Sections 141(f) and 242 of the General Corporation Law of the State of Delaware (i) approving the foregoing amendment to the Company's Amended and Restated Certificate of Incorporation, (ii) declaring such amendment advisable, and (iii) directing that such amendment be submitted to the stockholders of the Company for approval thereby.

**FOURTH:** The foregoing amendment to the Company's Amended and Restated Certificate of Incorporation was duly adopted by the stockholders of the Company in accordance with the applicable provisions of (i) Sections 242 and 228 of the General Corporation Law of the State of Delaware and (ii) Article Seventh of the Company's Amended and Restated Certificate of Incorporation.
