RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS, dated as of April 30, 2015 (this "Release"), is made by GENERAL ELECTRIC CAPITAL CORPORATION, as agent for the Secured Parties (in such capacity, the "Agent"), in favor of IMPLUS FOOTCARE, LLC ("Implus"), YAKTRAX LLC and TRIGGER POINT PERFORMANCE, INC. (collectively, the "Grantors"). Unless otherwise defined herein, capitalized terms used herein have the meanings given to them in the Credit Agreement referred to below or, if not defined therein, the Guaranty and Security Agreement referred to below.

WHEREAS, pursuant to the terms of that certain Credit Agreement, dated as of October 31, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Grantors and certain of their Affiliates party thereto, the financial institutions party thereto from time to time (collectively, the "Lenders") and the Agent, the Lenders provided a credit facility to Implus;

WHEREAS, pursuant to the terms of that certain Guaranty and Security Agreement, dated as of October 31, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement"), among the Grantors and certain of their Affiliates party thereto in favor of the Agent, to secure the prompt and complete payment and performance of all Secured Obligations, each Grantor granted to the Agent a continuing security interest and Lien upon all personal property of such Grantor, whether tangible or intangible, including the Patent Collateral (as defined in the applicable patent security agreement below), whether then owned or thereafter acquired, and wherever located;

WHEREAS, pursuant to the Guaranty and Security Agreement, the applicable Grantors executed and delivered the following (collectively, the "Patent Security Agreements"):

- (a) that certain Patent Security Agreement, dated as of October 31, 2011 and recorded in the United States Patent and Trademark Office on November 1, 2011 at Reel 027154 / Frame 0441;
- (b) that certain Patent Security Agreement, dated as of October 17, 2012 and recorded in the United States Patent and Trademark Office on October 19, 2012 at Reel 029156 / Frame 0569;
- (c) that certain Patent Security Agreement, dated as of July 26, 2013 and recorded in the United States Patent and Trademark Office on August 5, 2013 at Reel 030960 / Frame 0042;
- (d) that certain Patent Security Agreement, dated as of July 18, 2014 and recorded in the United States Patent and Trademark Office on July 18, 2014 at Reel 033359 / Frame 0929; and
- (e) that certain Patent Security Agreement, dated as of November 17, 2014 and recorded in the United States Patent and Trademark Office on November 18, 2014 at Reel 034282 / Frame 0733;

WHEREAS, pursuant to the Patent Security Agreements, the Grantors granted, mortgaged, pledged and hypothecated to the Agent a continuing security interest and Lien upon the Patent Collateral described therein, including the items set forth on Schedule I; and

WHEREAS, the Agent has agreed to release its grant, mortgage, pledge, hypothecation and security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Agent hereby terminates the Patent Security Agreements, and hereby terminates, cancels and releases any and all grants, mortgages, pledges, hypothecations, security interests and other Liens that it has in, to and under the Patent Collateral of each Grantor, without recourse, representation, warranty or other assurance of any kind by the Agent as to the Agent's rights in any Patent Collateral, the condition or value of any Patent Collateral, or any other matter.


2. Authorization to Record. The Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.

3. Governing Law; Electronic Delivery of Signature Pages. This Release shall be governed by and construed in accordance with the laws of the State of New York. Delivery of an executed counterpart of this Release by facsimile or other electronic transmission shall be as effective as delivery of an original copy of a manually executed counterpart hereto.
