ASSIGNMENT AGREEMENT

ASSIGNOR hereby sells, assigns, transfers and sets over to ASSIGNEE, its successors and permitted assigns, Assignor's entire right, title and interest in and to the Patents, including (without limitation) all divisions, reissues, substitutions, continuations and extensions thereof, all priority rights under the International Convention for the Protection of Industrial Property for every member country (and any other international convention or treaty), any and all Letters Patent and reissues and extensions of Letters Patent granted thereon and any and all rights corresponding to any of the foregoing throughout the world (all collectively the "Patents") and any and all accounts, contract rights, warranties, litigation claims and rights, including the right to sue for and collect upon all claims for profits and damages as a result of past, present or future infringement, if any.

ASSIGNOR, hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and any Official of any country or countries foreign to the United States of America whose duty it is to issue letters patent, to issue and record an assignment of letters patent for said Patents to ASSIGNEE, as ASSIGNEE of the entire right, title and interest in, to and under the same, for the sole use and behalf of the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND ASSIGNOR hereby further covenants and agrees that the ASSIGNOR, will, at any time, when called upon to do so by the ASSIGNEE, its successors, legal representatives, or assigns, take reasonable steps to promptly communicate to the ASSIGNEE, its successors, legal representatives, or assigns, as the case may be, any facts known to ASSIGNOR respecting said discovery or invention, and execute and deliver any and all lawful papers that may be necessary

or desirable to perfect the title to the Patents in the ASSIGNEE, its successors, legal representatives and assigns and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and perfect title in the Patents in ASSIGNEE, all without further compensation but at the expense of the ASSIGNEE, its successors, legal representatives and assigns.
