ASSIGNMENT

Whereas, LIXIAO WANG, residing at 3059 Farview Lane, Orono, Minnesota 55356 ("Assignor"), has made invention(s) for which United States and foreign patents and patent applications have been filed or will be filed and are identified on the attached Schedule 1;

Whereas, UROTRONIC, INC., a Delaware corporation having a place of business at 1205 Oakview Road, Long Lake, Minnesota 55356 ("Assignee"), desires to acquire the entire right, title and interest in and to drug coated balloon catheters only for urological applications of the United States and foreign patents and patent applications identified on the attached Schedule 1 and in and to the inventions described and claimed therein (the "Patents"). The entire rights of any other nonvascular applications (such as sinus and digestive system) are not included in the assignment and other intellectual properties pursuant to the terms and conditions of this Assignment; and

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, and its successors and assigns the following:

- (1) The entire right, title and interest to the Patents including the inventions described or claimed therein, to each U.S. and foreign patent application and patent from which the Patents claim priority, in whole or in part, and to each U.S. and foreign patent application and patent that claims priority to the Patents, in whole or in part;
- (2) The entire right, title and interest to any United States or foreign patents that may issue with respect to the inventions described or claimed in the Patents;
- (3) The entire right, title and interest to any renewals, reissues, extensions, substitutions, continuations, continuations-in-part, or divisions of the Patents, and all foreign applications based thereon;
- (4) The right to apply for patents in foreign countries in its own name and to claim any priority rights to which such foreign applications are entitled under international conventions, treaties or otherwise; and
- (5) The right to enforce patent rights to such Patents as fully and entirely as the same would have been held and enjoyed by the Assignors if this assignment had not been made; together with all claims by Assignors for damages by reason of past infringement or for provisional rights and including the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, and other legal representatives.
- (6) The entire rights, title and interest in any intellectual property concerning Drug Coated Balloon for urologic application that Assignor may invent/create at any time between the date of the Assignment and the end of the second year after Assignor reduces its holding of stock of the Assignee to less than 5%.

Assignor further agrees for itself and for its successors and assigns to execute and deliver without further consideration any further applications, assignments or other documents and to perform such other lawful acts as Assignee, its successors and assigns may deem necessary to fully secure, maintain and enforce its rights, title or interest as outlined herein.


Assignor shall avoid any financial conflict of interests concerning drug coated balloon catheters for urological applications during any time before the end of the second year after Assignor reduces its holding of stock of the Assignee to less than 5%.

Assignor hereby authorizes and requests the Commissioner of Patents to issue to Assignee any patents that may be granted in accordance with this Assignment.


