ASSIGNMENT

THIS ASSIGNMENT is made the 26 day of April 2010 between ACADEMISCH MEDISCH CENTRUM BIJ DE UNIVERSITEIT VAN AMSTERDAM, a legal entity existing under the laws of The Netherlands, having its registered office in Amsterdam, The Netherlands, and its principle place of business at Meibergdreef 9, 1105 AZ Amsterdam (hereinafter called "the Assignor") of the one part and AIMM THERAPEUTICS BV (formerly AIMM Antibodies BV) a company incorporated under the laws of The Netherlands, having its registered office in Amsterdam, The Netherlands, and its principle place of business at Meibergdreef 45, PO Box 22700, 1100 DE Amsterdam, The Netherlands (hereinafter called "the Assignee") of the other part.

WHEREAS:

a) The Assignor is co-applicant in, by virtue of an assignment from Hergen Spits, and thereby possesses a right, title, and interest to International Patent Application No. PCT/NL2008/050333 filed May 20, 2008, in the name of Hergen Spits, Tim Beunmont, Etsuko Yasuda, and Mark Jeroen Kwakkenbos for RSV-SPECIFIC BINDING MOLECULES AND MEANS FOR PRODUCING THEM;

b) In accordance with the terms of the September 23, 2009 Amendment No. 1 to the Intellectual Property Exclusive License Umbrella Agreement dated April 20, 2005, by and between ASSIGNOR and ASSIGNEE, ASSIGNOR has sold, assigned, transferred and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, its entire right, title and interest in, to and under the intellectual property rights subsisting in antibodies which target Respiratory Syncytial Virus ("RSV Antibodies") and all Patents which may be granted thereon;

c) The parties hereto have agreed that said International Patent Application and all Patents which may be granted thereon should be transferred by the Assignor to the Assignee for the consideration hereinafter set forth.

NOW THIS DEED WITNESSETH as follows:

1. For good and valuable consideration by the Assignee to the Assignor, the receipt whereof is hereby acknowledged, the Assignor as beneficial co-owner hereby assigns transfers and releases unto the Assignee ALL THAT the Assignors' right title share and interest in and to the said International Patent Application and the full sole and exclusive privileged which may be

obtained in respect thereof in any of the countries individually designated in said application.

2. The Assignor shall at the request and expense of the Assignee execute all documents and do all acts and things as may be necessary or proper for obtaining a Patent or like exclusive privileges in respect of said International Patent Application and in all countries designated therein.

3. The Expressions "the Assignor" and "the Assignees" shall where the context so admits include their respective legal successors representatives and assigns.
