This Agreement is effective as of 28 July 2009 and is made between:

Chris Seldon, of 10, James Terrace, Ynyshir, Porth, Rhondda, CF39 0EA, UK;

Chris Seldon Laboratories Limited of 10, James Terrace, Ynyshir, Porth,

Rhondda, CF39 0EA, UK;

and Norgine Limited, of New Road, Tir-Y-Berth, Hengoed, Mid Glamorgan,
CF82 8SJ, UK.

WHEREAS:

(A) Chris Seldon has, jointly with employees of Norgine Limited, made an invention arising from Norgine Project No. NRL 0701, referred to by the patent case number PN1120 "MOVICOL Concentrate (Formulation)" (Abel & Imray reference 14066), and the relating to a liquid concentrate of MOVICOL. ("the Invention");

(B) The parties have agreed (as evidenced by agreements dated 15 February 2007 and 17 November 2008) that all the rights, title and ownership in the Invention arising from the involvement of Chris Seldon, shall vest in Norgine Limited or its Affiliated Companies.

NOW IT IS HEREBY AGREED as follows:

1. Chris Seldon and Chris Seldon Laboratories Limited, in consideration of consultancy fees paid by Norgine Limited, hereby confirm that all rights arising from Chris Seldon's making of the Invention have been assigned to Norgine Limited. To the extent, if any, that the entire right, title and interest in and to the Invention, and the right to make application for the grant of a patent or other

protection in any country of the world, and including the right to claim priority from any such application, have not already been assigned, they are hereby assigned.

2. Chris Seldon and Chris Seldon Laboratories Limited hereby agree that they will at the request and at the cost of Norgine Limited execute all documents and do all things as may be reasonably required for obtaining the grant of a patent or other protection in any country of the world in respect of the Invention and for vesting the Invention and such patent or other protection in Norgine Limited or in Norgine Limited's affiliate Norgine BV or otherwise as Norgine Limited shall direct.
