PATENT ASSIGNMENT

1. Assignment.

(a) Assigned Patents. Assignor hereby sells, assigns and transfers to Assignee, its successors, assigns and legal representatives, the entire right, title and interest for all countries, in and to any and all of the Assigned Patents which are disclosed and claimed, and any and all of the patents which are disclosed but not claimed, in any of the Assigned Patents or the patent applications, if any, and in and to all United States and foreign patents issuing from any of the applications and all divisional, continuing, substitute, renewal, reissue, and all other patents and applications for United States Letters Patent or other related property rights in any and all foreign countries which have been or shall be filed on any of the Assigned Patents disclosed in any of the patents or the patent applications, if any, and in and to all original and reissued patents or related foreign documents which have been or shall be issued on any such Assigned Patents or improvements, including the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements of the rights assigned under this Assignment. Assignee hereby accepts assignment of the Assigned Patents.

(b) The Parties hereby request and authorize the relevant authority at the United States Patent and Trademark Office and/or the applicable foreign authorities to record Assignee as the assignee and owner of the Assigned Patents.
