PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT (this "Release") is made as of May 14, 2015, by GE CANADA FINANCE HOLDING COMPANY, in its capacity as Canadian Agent ("Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Coinamatic Canada Inc., a Canadian corporation ("Grantor") and Secured Party were parties to that certain Patent Security Agreement dated as of February 21, 2013 (the "Security Agreement") pursuant to which Grantor granted a security interest to Secured Party in certain Patents ("Patents") and Patent Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Patents set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on February 28, 2013, at Reel 029901, Frame 0107;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Patents and Patent Collateral and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Patent Collateral"):

(i) all of its Canadian issued Patents, including, without limitation, those referred to on Schedule 1 hereto;

(ii) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and

(iii) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.


