US Provisional Application 61/772,962, filed 05 March 2013, entitled CMV VECTORS WITH EXOGENOUS ANTIGENS and



We hereby grant the Assignee the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.




