THIS DEED made on the 8th of October 2014
BETWEEN

- (1) **HOVIONE INTER AG** a company incorporated under the laws of Switzerland with registered number CHE-101.872.084, having its registered office at Bahnhofstrasse 21, 6000 Luzern 7, Switzerland (the "Assignor"); and
- (2) **HOVIONE SCIENTIA LIMITED** a company incorporated under the laws of Ireland with registered number 549103, having its registered office at Loughbeg, Ringaskiddy, Co. Cork, Ireland (the "Assignee").

NOW IT IS AGREED as follows:

- (A) The Assignor is the owner of the patent listed in Schedule 1 (the "Patent").
- (B) The Assignor and the Assignee entered into a deed of assignment of intellectual property dated on or about the date of this Deed pursuant to which the Assignor agreed to sell certain of its intellectual property (including the Patent) to the Assignee.
- (C) The Assignor enters into this Deed to assign absolutely the Patent to the Assignee.

NOW THIS DEED WITNESSES as follows:

1. **ASSIGNMENT**

- 1.1 **Assignment:** The Assignor, as sole legal and beneficial owner, hereby assigns and agrees to assign to the Assignee absolutely the Patent (the "Assignment" or "this Assignment").
- 1.2 **Scope:** The Assignment effected by this Clause 1 shall include, without limitation, the assignment and transfer of:
 - (a) all patents and other intellectual property that may be granted pursuant to the application listed in Schedule 1, as well as all patents and other intellectual property that may derive priority from or have equivalent claims to or be based upon the Patent in any country of the world (and including supplementary protection certificates, divisions, continuations, continuations in part, reissues and extensions), and references to the Patent in this Assignment shall be deemed to include all such items of property;
 - (b) all rights of action, powers and benefits arising from ownership of the Patent, including without limitation the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising prior to, on or after the date of this Assignment; and
 - (c) all rights or ownership of any materials that form part of the Patent.

2. **POWER OF ATTORNEY**

The Assignor hereby irrevocably appoints the Assignee as its attorney in its name to execute any document and do any act or thing which may be necessary to comply with the provisions of Clause 1 above.

3. **LAW & JURISDICTION**

3.1 **Governing Law:** This Deed and the relationship between the parties shall be governed by, and construed in accordance with, the laws of Ireland.

3.2 **Jurisdiction:** The Irish courts shall have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed and the parties submits to the exclusive jurisdiction of the Irish courts for that purpose.

4. **COUNTERPARTS**

This Deed may be executed in two or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.

5. **CERTIFICATE OF VALUE**

It is hereby certified that this Deed gives effect to a transfer of intellectual property within the meaning of section 101 of the Stamp Duties Consolidation Act 1999.

IN WITNESS OF WHICH, this Deed has been duly executed and delivered by the undersigned signatories on behalf of the parties on the date first above written.






